

**GENERAL TERMS OF SALE**  
**COLD-FORMED SECTIONS WITHOUT APPROVAL**  
**of May 12, 2022**  
**(due to sales by "Huta Pokój Profile" Sp. z o.o.)**

1. The sale of cold-formed sections without approval as to the quantity and dimensions depends on the Customer's choice.
2. The order is valid until the end of the calendar year in which it was sent.
3. The minimum purchase is 500 kg with full bundles.
4. stock levels require confirmation with an employee of the sales department.
5. Reservation of cold-formed profiles without approval is valid for 3 working days. The reservation should be prepaid up to 4 working days. After these days the reserved material is returned to the stock for sale and any prepayment is returned to the Customers's account.
6. The settlement is based on the actual weight of the products.
7. Prices from the date of receipt are valid for the final settlement of sale - published on the website: <https://www.hutapokoj.eu/en/online-storehouse/non-approved-cold-formed-sections/>
8. The following forms of payment are allowed: bank transfer, card payment after loading and prepayment.
9. In case of payment by bank transfer, the amount should be paid within the agreed payment date, counting from the date of sale of the material. If the deadline is exceeded, statutory interest will be charged.
10. Loading is possible after sending the "Loading data", which should include:
  - 10.1. The loading data should be sent the day before the scheduled loading between 6.00 a.m. and 2.00 p.m. by e-mail to the sales employee responsible for the order.
  - 10.2. The loading data should include the following information:
    - the name of the company that ordered the material,
    - driver's name and surname,
    - driver's ID number (depending on the type, e.g. ID card, passport or driving license),
    - car and trailer registration number,
  - 10.3. If the loading data does not match the actual driver's data, the loading will have to wait until the correct data is sent.
  - 10.4. If the authorization will not be sent in the above-mentioned time, waiting for loading will be extended.
